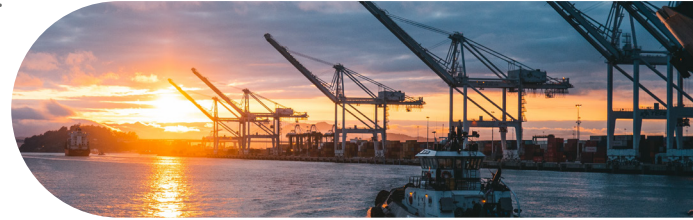

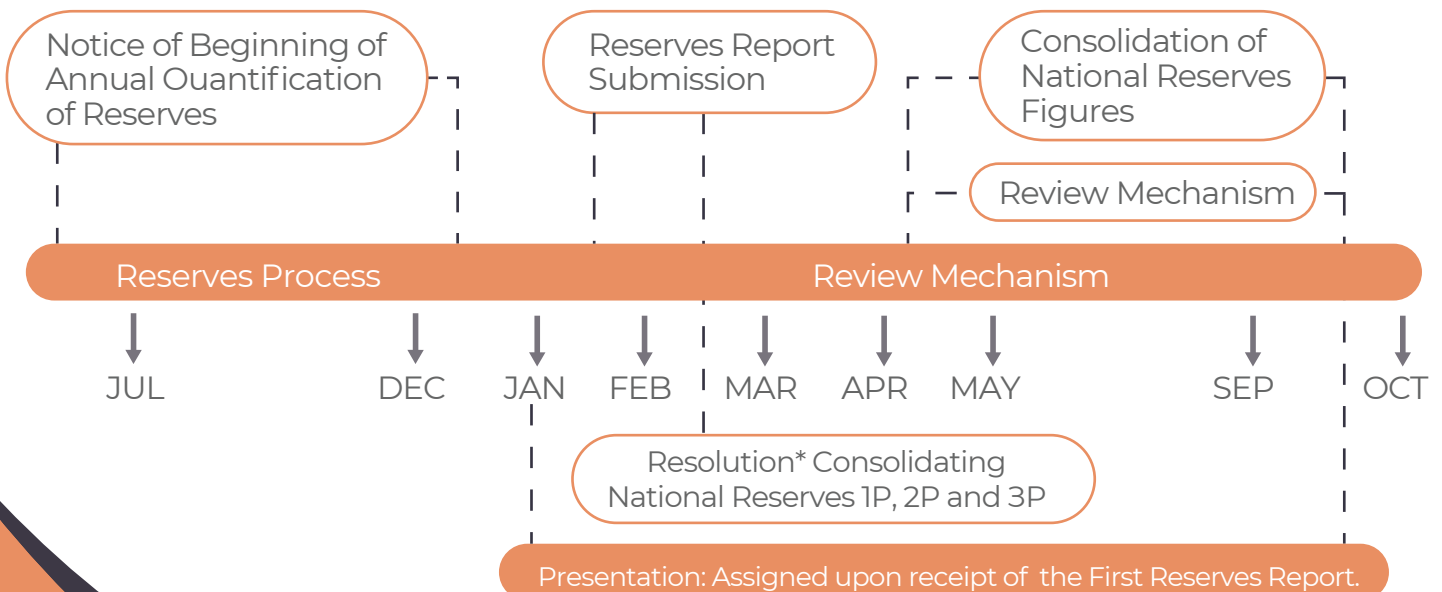


Technical and Regulatory Assistance for the Annual Reserves Process

Annual Reserves Quantification Schedule



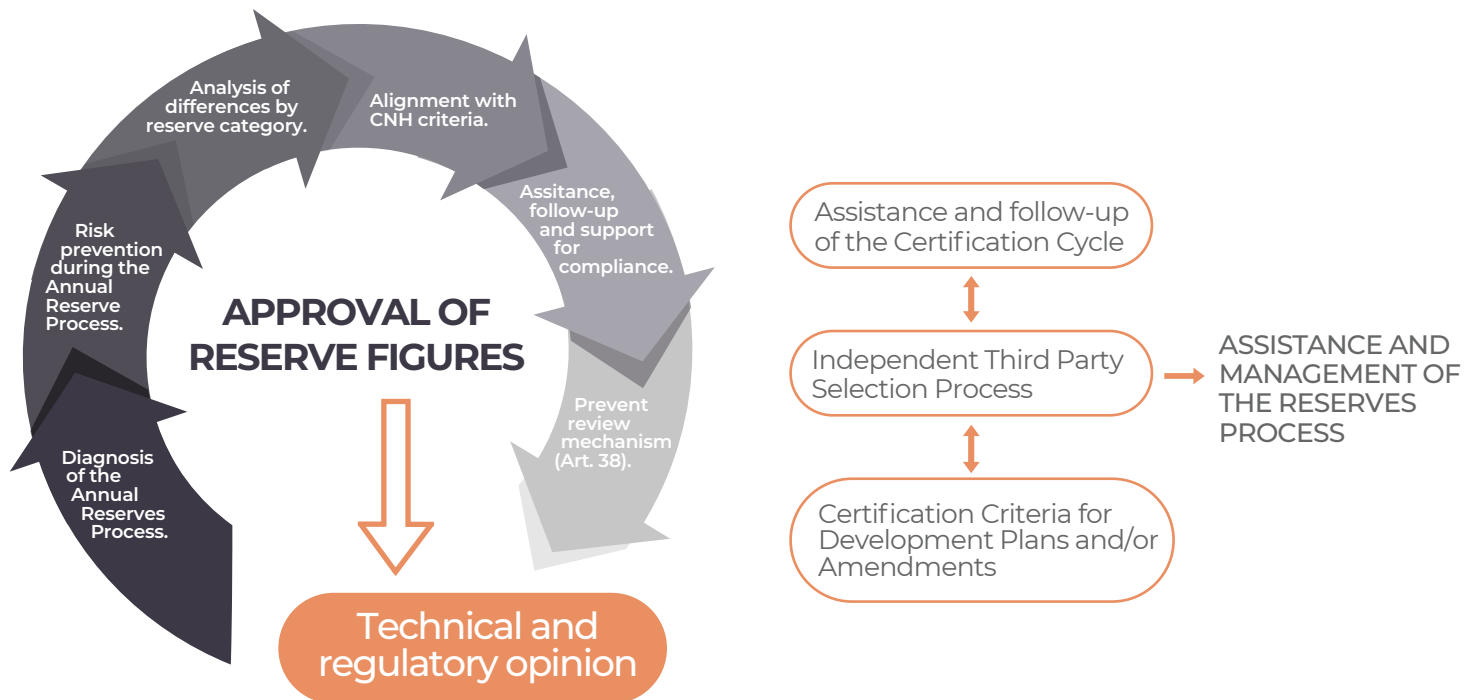
NOTE: The calendar is structured according to the Annual Calendar of Reserves described in the Guidelines that regulate the procedure for the quantification and certification of the Nation's Reserves.

- **Review Mechanism:** In the event that there are figures subject to the Review Mechanism, the process is extended until the second week of September.

Our Services:

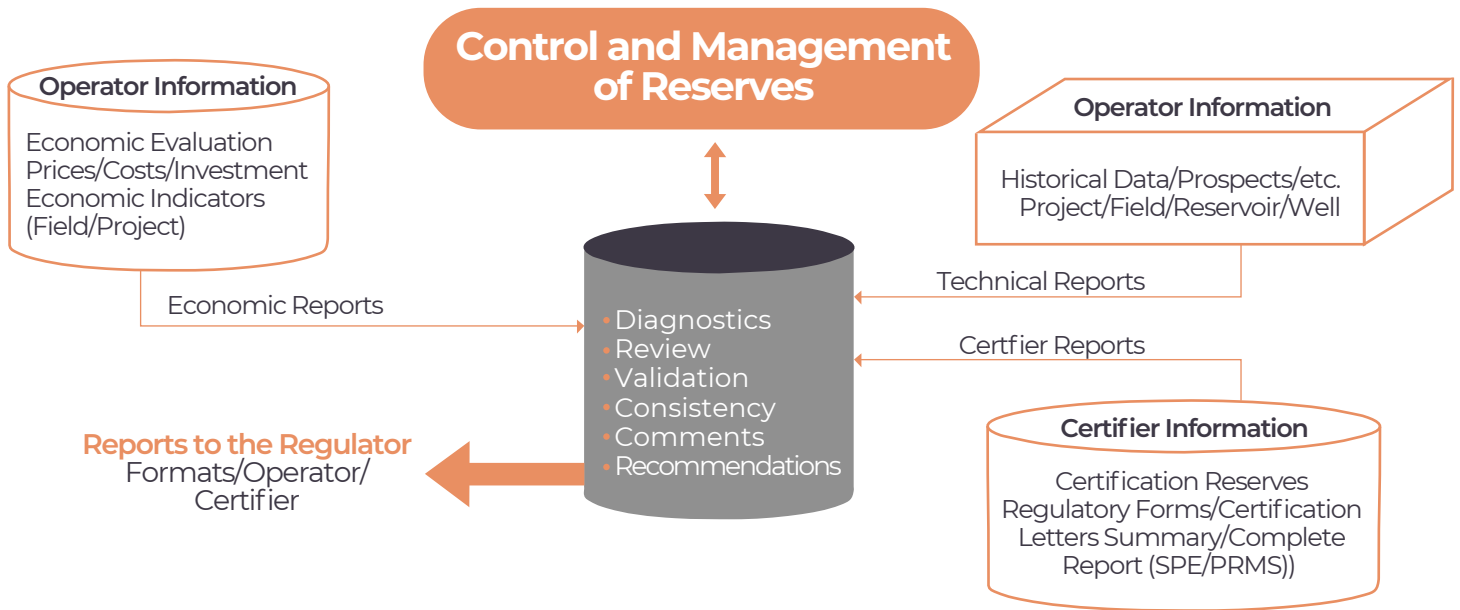
- Technical and regulatory assistance during the annual quantification and certification process.

- Advice and follow-up for the Independent Third Party Selection process and Certification Cycle.



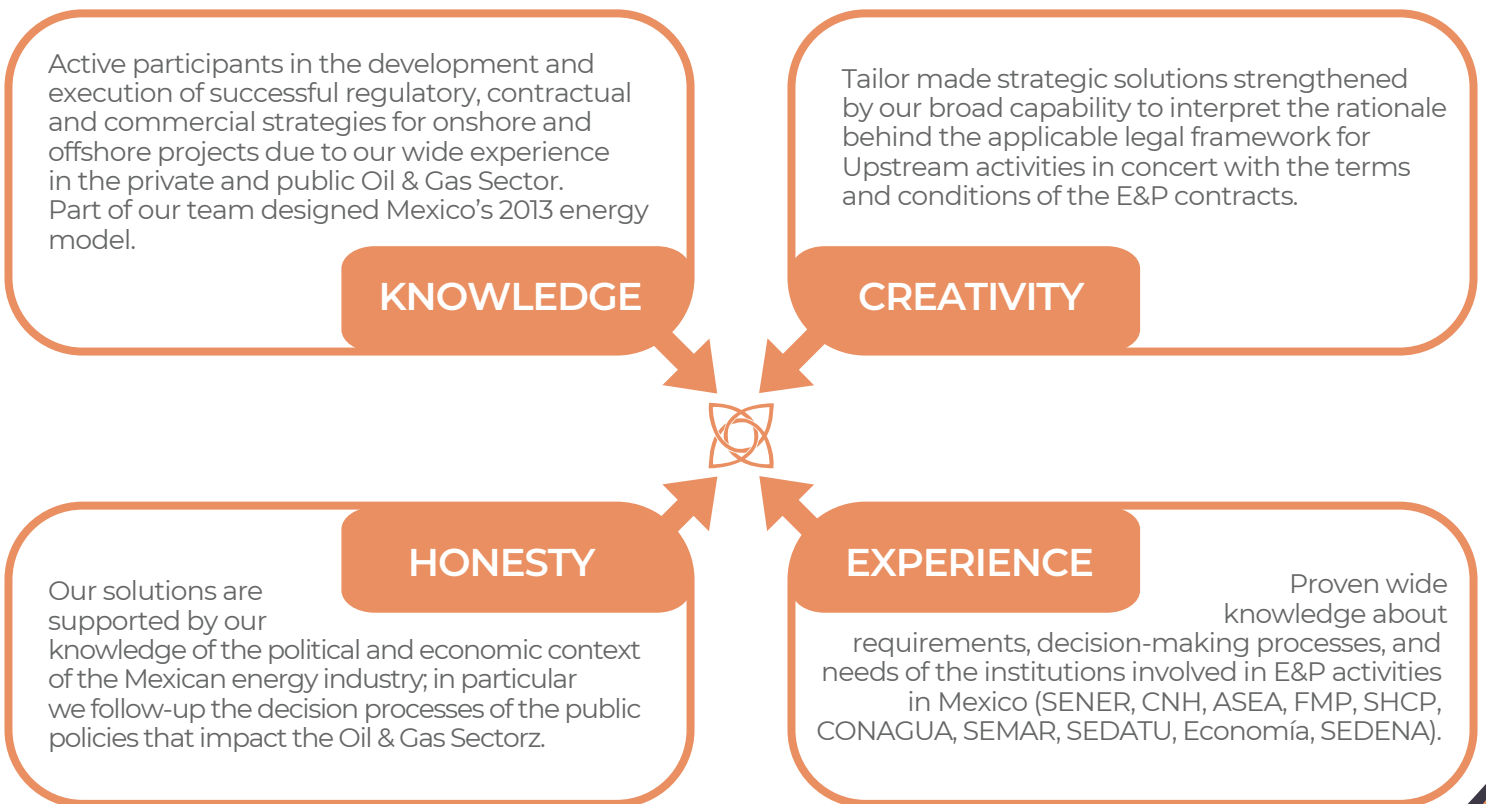
Control and Management
